

§ 1 General

Between 29th August and 31st August 2018, Rail Nation is giving away 100x 10,000 Gold. Every Rail Nation player who logs into any Rail Nation game world during the event, will take part in the prize draw. Every player who's active during this time will be automatically entered into the prize draw and will have a chance of winning one of 100 Gold packages. 100 winners will be drawn by lottery from among all participants.

§ 2 Conditions of participation

The event takes place from 29th August 12:00am until 31st August 2018, 11:59pm. All natural and legally competent people aged 18 or older may take part. To take part, a person must simply log into any Rail Nation game world during the event. Exactly one login counts per person. Due to legal provisions, people residing in Italy and Spain are excluded from participation. Employees of the promoter and their relatives are also excluded from taking part. By taking part, the participant agrees that their name will be published on the Internet in the event that they win. Participation is only possible during the period indicated in the prize draw description. Any legal recourse is precluded.

§ 3 Prizes

The prizes are 100 packages, each worth 10,000 Gold (in-game credits). Each participant can win a maximum of one package. The prize will be credited to the respective account of the winning avatars. For deleted avatars, the Gold prize can be transferred to another game world. A change or cash payout of the prize is excluded.

§ 4 Liability

Claims of damages against the organiser in relation to the prize draw are, within the legal framework, excluded regardless of the legal basis, unless the organiser has wilfully or gross negligently violated its duties. Furthermore, the organiser is not liable for damages incurred through disturbance to the availability of the prize draw website in the event of technical disruptions and force majeure events, as well as third-party attacks against the prize draw website. The organiser will however take every reasonable measure to ensure the reliability and operation of the prize draw website. In addition, the organiser does not guarantee the proper functioning of the prize draw website on the participant's device.

§ 5 Data protection

The organiser ensures that the highest possible data privacy standard is maintained for the prize draw and that all related legal provisions will be observed. The organiser will not pass on personal data to third parties or sell address data. The organiser stores personal data of the participant only for the purpose of the prize draw. All data will be erased at the latest 30 days after the end of the prize draw. The participant expressly agrees to the storage and use of their submitted personal data for the above-mentioned purpose.

§ 6 Severability clause

Should individual provisions of these conditions of participation be void or a regulatory omission exist, the other regulations shall remain unaffected. The void provision or omission shall be replaced by a regulation that comes closest to the purpose of the agreement and the legal provisions.

§ 7 Jurisdiction / Applicable law

German law applies exclusively in the event of any disputes. As far as legally permissible, the place of jurisdiction is determined to be the registered address of the organiser. If the participant has no

legal domicile in Germany or relocates their domicile abroad after taking part, the registered address of the organiser shall be the agreed place of jurisdiction.

§ 8 Selection process

The winners will be determined by drawing lots within 7 days of the end of the prize draw. Purchasing in-game products or services will have no impact on the chance of winning. Any legal recourse is likewise precluded here.
